



# **Western Chances Programs**



I am pleased to report that the Western Chances Programs Committee has met the Terms of Reference for the Subcommittee in 2005/6.

The committee has overseen the development and operation of programs undertaken for 2005/6 including the development of program guidelines, procedures, assessing risks and monitoring and evaluating outcomes.

Our data program DIGITS has aided immeasurably in supporting the organisation and analysis of scholarships and programs.

The Western Chances Programs Subcommittee works closely with other Western Chances committees and reports to the Board at each Board meeting.

The Programs committee is responsible for programs related to:

- engagement with schools and other referral organisations;
- the scholarship making process;
- scholarship recipient support;
- student pathways; Links Programs
- data collection;
- research and evaluation of Western Chances.
- Links Programs
- Opportunity programs

Western Chances scholarships provide support with purchasing computers, internet connection, memory sticks and scanners, text books, and travel cards for a wide range of interests including music, dance, arts, and general academic excellence.

# **Scholarship Program**

# Western Chances Scholarships

Western Chances Scholarship Program is our core program providing scholarships through a bi-annual (April/May and September/October) grant process. Scholarships are awarded at the discretion of the Western Chances Board to applicants who best meet the criteria and demonstrate their passion to develop their talents. Scholarships are merit based and average about \$1,000 per successful scholarship applicant.

Term 1 and Term 3 are the two opportunities throughout the year for scholarship renewals. Renewals are not automatic and relevant forms must be completed by the nominator and scholarship recipients by set dates.





# Western Chances-Victoria University (VU) 'Access' Scholarships

These scholarships will enable students to develop their skills and soar to new horizons in both Higher Education and TAFE. VU are offering upto 35 opportunities for students who have been nominated by Western Chances. Students will be guaranteed a VU scholarship of at least \$1,000 per year and, on application, may be eligible to receive other scholarships from Western Chances and VU.

# **Opportunities Programs**

# Cricket - Crusaders

Western Chances, the Crusaders–Merv Hughes Foundation and the Footscray Edgewater Cricket Club deliver a unique program of coaching and development for young cricketers in September-October each year. The program involves up to 200 participants in a training program overseen by Merv Hughes and other current and former first class cricketers, in conjunction with the Crusaders network and Footscray Edgewater Cricket Club. At the conclusion of the training program, two 20/20 matches are played, and a further group will go through and participate in the Crusaders Secondary Schools Cup. Footscray Edgewater Cricket Club hosts the training program.

# Media - Australian Centre for the Moving Image (ACMI)

Western Chances and ACMI deliver 2 programs per year for young people to learn the skills of digital storytelling – including visual storytelling, scriptwriting and digital media. The programs involve students and teachers participating for one full week of the school holidays in July and September at ACMI's state-of-the-art studio at Federation Square, Melbourne.





# Music – Orchestra Victoria (OV)

Western Chances and OV deliver 1 mOVe workshop per year, enabling 40 young people to rehearse and perform for 2 full days alongside 12 of OV's professional musicians, who all have a passion for educating young people. The workshop includes full orchestra rehearsals conducted by a leading education specialist and sectional rehearsals led by OV musicians.



# Science/Engineering – The Siemens Science Experience (TSSE)

Western Chances, in partnership with Siemens, TSSE and VU provide 100 Year 9 students in the Western suburbs the opportunity to participate in TSSE program – an innovative 3 day program held in December each year where students gain valuable hands on experience and insights into the fields of Science and Engineering.





# **Free Debate**

Free Debate (FD) is a not-for-profit organisation that operates with the aim of helping people from traditionally disadvantaged backgrounds gain skills in communication and persuasion. Specifically, FD targets groups that face economic or social disadvantage, such as; schools and students from low socio-economic backgrounds, migrants, refugees, prisoners, etc. FD can provide training and resources to help people develop confidence in public speaking as well as assisting with the development of critical thinking skills that allow for articulate and reasoned debate.





# Variety /Bash Club/Bike Program

In December 2005, The Variety Club Children's Charity offered Western Chances 20 bikes and helmets to distribute to Scholarship Recipients who would benefit greatly from a new set of wheels

The Variety BASH program has given young people from Western Chances and Open Family (who wish to be involved in the automotive industry) the chance to build a bash car. An exciting opportunity for the young people below.

# **LINKS Program**

We aim to add value to our scholarship recipients through our Links Program, targeted at scholarship recipients who are in secondary school and require assistance in obtaining experience in the workforce. The work experience is paid vacation employment combining mentoring/leadership relevant to their talents and goals and assists in the transition from secondary school to tertiary/further education. Through this program, Western Chances creates connections between young people and employer organisations in our network – facilitating 'right fit' employer-employee partnerships.

# Young Western Leaders Program

The Western Chances Young Leaders Program delivers opportunities to scholarship recipients to enhance their skills in specific skill areas and to assist in the development of their leadership qualities. Skills development areas include: Debating, Presentation Skills, and Interview Skills. Program examples include Free Debate and the Young Western Leaders 2 day Summit.



# Western Chances Marketing and Development Report

# Treasurer's Report for Western Chances

It is once again with considerable pleasure that I present Western Chances' accounts for the 05/06 Financial Year.

The focus of the Sub Committee for Finance over the last 12 months has been to ensure that the appropriate systems and controls are in place to provide the proper financial and governance management tools for the organisation. I am confident that this has been achieved with all systems and controls being reviewed annually by our independent auditors, adopted by the Board as appropriate and implemented.

Our scholarship recipients and partners can be assured that we have the foundations in place to provide the right level of governance and transparency necessary for a growing organisation such as Western Chances.

Growth this year has been significant across the organisation. We have seen:

- A. Net assets growing in excess of 80%
- B. Donations growing by more than 40%
- C. And most importantly, the Scholarships granted growing almost threefold for the 05/06 year compared to the 04/05 year

A key directive of the Investment Committee this year has been to ensure we make the most prudent investment decisions for funds raised to date. Through the establishment of an investment corpus and in conjunction with our existing partners, we have the ideal partnership to underpin the sustainability of the organisation moving forward.

I would like to take this opportunity to thank my fellow members of the Finance Committee for their invaluable input along with the staff of Western Chances and the generous contribution from our pro bono partners such as our external auditors

The dedication of all those involved in the organisation will continue to ensure the sound financial platform and systems we have established in our formative years will provide the environment to continue to grow our organisation into the future.

Next year we will continue to work diligently building on our sound footing ensuring Western Chances' financial sustainability in the years ahead.

# 2. PRINCIPAL ACTIVITY

The principal activity of the Company during the financial year was, in conjunction with the Education Foundation Inc., providing scholarships to disadvantaged young people to ensure that a lack of resources does not prevent them from obtaining educational, cultural or social opportunities.

## 3. SURPLUS / DEFICIT

The net amount of the surplus of the Company for the financial period was \$279,880 (2005: \$124,586). The Company is exempt from income tax.

Operating income for the financial year was \$565,696 (2005: \$265,778) from donations, sponsorships, and bank interest.

Total expenditure of \$285,817 (2005: \$141,192) included scholarship payments of \$151,061 (2005: \$58,766)

#### 5. SIGNIFICANT CHANGES IN THE STATE OF AFFAIRS

Western Chances was endorsed with Deductible Gift Recipient status on 24 February 06. As a result of this endorsement, Education Foundation Inc are no longer required to distribute donations. There have been no other significant changes in the state of affairs for the period ended 30 June 2006.

## 1. CORPORATE INFORMATION

The Directors are of the view that the company is not a reporting entity. These financial statements have been prepared as a special purpose financial report solely to meet the Corporations Act (2001) requirements to prepare financial statements. In the opinion of the directors, the accounting standards applied in the preparation of these financial statements are appropriate to meet the needs of the members, and comply with all accounting standards applicable to general purpose financial statements, except for AASB 114 "Segment Reporting", AASB 124 "Related Party Disclosures", AASB 132 "Financial Instruments: Presentation".

Western Chances is a company limited by guarantee. The liability of members is limited. It was incorporated on 27 August 2004.

# 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

# (a) Basis of Preparation

This special purpose financial report has been prepared for distribution to the members to fulfil the directors' financial reporting requirements under the Corporations Act 2001. The accounting policies used in the preparation of this financial report, as described below, are consistent with the previous years, and are, in the opinion of the directors', appropriate to meet the needs of members:

- (i) The financial report has been prepared on a historical cost basis
- (ii) The financial report is presented in Australian dollars and all values are rounded to the nearest dollar unless otherwise stated.
- (iii) The disclosure requirements of Accounting Standards and other financial reporting requirements in Australia do not have mandatory applicability to Western Chances because it is not a 'reporting entity'. However, the directors have prepared the financial report in accordance with Accounting Standards and other financial reporting requirements in Australia with the following disclosure exceptions:

# (b) Statement of compliance

The financial report complies with Australian Accounting Standards, which include Australian equivalents to International Financial Reporting Standards (AIFRS), Compliance with AIFRS ensures that the financial report, comprising the financial statements and notes thereto, complies with International Financial Reporting Standards (IFRS).

# (c) Cash and Cash Equivalents

Cash on hand and in banks is stated at the lower of cost and net realisable value. For the purpose of the Cash Flow Statement, cash includes cash on hand.

# (d) Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the company and the revenue can be reliably measured.

# (e) Plant and Equipment

Plant and equipment is stated at cost less accumulated depreciation and any accumulated impairment losses.

Depreciation is calculated on a straight-line basis over the estimated useful life of the assets as follows:
